Approval of Prior Minutes

KDOT – Bridge Project West of Oswego – Traffic Routing

KDOT District Engineer Wayne Gudmonson, Area Engineer George Dockery and Community Affairs Manager Kristy Kelley talked to Commissioners about traffic detours concerning the Labette Creek Bridge west of Oswego if the bridge is replaced in a few years; in 2017 a field check will be done on the bridge. There was discussion from both sides as to possible solutions for the detour.

Area Engineer George Dockery also informed Commissioners that two traffic studies had been done in Labette County: Edna City and Highway 59/Highway 160. KDOT will be sending Commissioners the results of the two studies.
