## **Health Department Director**

Labette County Health Director Lisa Hoppock, gave Commissioners an update on recent COVID-19 statistics in Labette County, as well as information on vaccine disbursement going forward.

## **Sick Leave Discussion**

County Clerk Gena Landis discussed use of employer paid sick leave versus employee sick leave for employees who are receiving the COVID-19 vaccination and having side effects that cause them to be ill and not be able to work. The County Commission extended the FFCRA benefits voluntarily. Under those guidelines, employees must have been instructed by a county health department or state agency, to quarantine or isolate due to a positive test result or contact quarantine to be eligible, and this instance would not apply. Commissioners agreed that employees who are unable to work due to vaccine side effects would need to use their employee sick leave.

#### **SPARK**

Parsons Community Development Director Laura Moore and Parsons Economic Development Director Jim Zaleski, discussed details of the SPARK extension and amounts remaining that will need to be spent.

#### CDBG-CV
