

**Labette County Board of Commissioners**  
**June 9, 2025**

**Convene**

Chairman Vincent B. Schibi called the regular session of the Labette County Board of Commissioners to order at 9:00 a.m. on June 9, 2025, at the Commission Room. Attendance: Tom Barrett, Present, Vincent B. Schibi, Present, Terry Weidert, Present.

**Others Present for the Meeting**

County Counselor Brian K. Johnson, and County Clerk Gena Landis.

**Approval of Minutes**

Commissioner Terry Weidert made a motion to approve the minutes of June 2, 2025. Tom Barrett seconded the motion. The motion passed by vote: Tom Barrett (Yes), Terry Weidert (Yes), Vincent B. Schibi (Yes).

**Surplus Property**

Chairman Vincent B. Schibi made a motion to declare a Pitney Bowes Connect + 2000, PCN-MSF Postage machine as surplus and allow Pitney Bowes to remove it upon delivery of the new machine. Tom Barrett seconded the motion. The motion passed by vote: Tom Barrett (Yes), Terry Weidert (Yes), Vincent B. Schibi (Yes).

**Resolution No. 2025-29-A**

Chairman Vincent B. Schibi made a motion to authorize the Board of Commissioners' signatures on Resolution No. 2025-29-A resolving invoices in the amount of \$40.00, which is a portion of the \$2,242.91 owed towards the delinquent taxes of Stanley and Michelle Altendorf. Tom Barrett seconded the motion. The motion passed by vote: Tom Barrett (Yes), Terry Weidert (Yes), Vincent B. Schibi (Yes).

**Labette Community College – Agreement for Purchase of Services**

Chairman Vincent B. Schibi made a motion to authorize the chairman's signature on the Agreement for Purchase of Services by and between Labette Community College and Labette County; said agreement provides for LCC to provide educational training programs to assist qualified employers to train their employees in job related skills and Labette County provides such services as classroom facilities, Equipment usage, Faculty, Consulting, Supplies and other services as may be agreed upon. Terry Weidert seconded the motion. The motion passed by vote: Tom Barrett (Yes), Terry Weidert (Yes), Vincent B. Schibi (Yes).

**Election Canvass Date**

Chairman Vincent B. Schibi made a motion to set the canvass date for the 2025 primary election to be held August 11, 2025 at 9:00 a.m. Terry Weidert seconded the motion. The motion passed by vote: Tom Barrett (Yes), Terry Weidert (Yes), Vincent B. Schibi (Yes).

**RNR**

Commissioner Terry Weidert made a motion to exceed the Revenue Neutral Rate. Vincent B. Schibi seconded the motion. The motion passed by vote: Tom Barrett (Yes), Terry Weidert (Yes), Vincent B. Schibi (Yes). Commissioners will also need to approve exceeding the RNR at a later date, when they have a proposed mill levy.

**Appraiser Budget**

Commissioners met with Appraiser Melody Kikkert to go over her 2026 budget.

## **Grader Quotes**

Public Works Director Sandy Krider and Assistant Director Ralph George presented commissioners quotes for new motor graders.

Foley Equipment, Chanute, KS, two 2024 - Cat 150-15J \$696,000.00

Murphy Tractor, Humboldt, KS, two 2025 – JD770G \$711,600.00

Commissioner Terry Weidert made a motion to authorize the purchase of two Cat 150-15J Motor Graders from Foley Equipment in the amount of \$696,000.00, with the two graders they will replace to be sold on Purple Wave after being declared surplus property. Ms. Krider will get financing bids. Vincent B. Schibi seconded the motion. The motion passed by vote: Tom Barrett (Yes), Terry Weidert (Yes), Vincent B. Schibi (Yes).

## **Department Head Discussion**

Several Labette County Department Heads met with commissioners to discuss Resolution 2025-28-A, a resolution appointing Melody Kikkert as a full-time appraiser. Concerns were raised about the fact that she was hired as a full-time appraiser for an annual salary of \$90,000.00 but will work reduced hours in Labette County due to the fact that she is also employed full-time by Montgomery County.

Chairman Vincent B. Schibi made a motion to rescind Resolution 2025-28-A. The motion failed for lack of a second.

## **Signature Authorization**

Chairman Vincent B. Schibi made a motion to authorize the County Clerk Gena Landis to electronically sign an agreement with Nationwide Retirement. Tom Barrett seconded the motion. The motion passed by vote: Tom Barrett (Yes), Terry Weidert (Yes), Vincent B. Schibi (Yes).

County Counselor Brian K. Johnson had previously read the document and had no objection to the agreement.

## **Executive Session**

Commissioner Terry Weidert made a motion to go into executive session for consultation with our attorney, a matter protected by the attorney-client privilege. To protect the privilege and the board's position (in litigation, potential litigation, administrative proceedings, etc.) Vincent B. Schibi seconded the motion. The motion passed by vote: Tom Barrett (Yes), Terry Weidert (Yes), Vincent B. Schibi (Yes). Also present was County Counselor Brian K. Johnson for a period of ten minutes to reconvene at 10:43 a.m. in the commission room.
