Approval of Minutes

Commissioner Terry Weidert made a motion to approve the minutes of March 10 2025. Tom Barrett seconded the motion. The motion passed by vote: Tom Barrett (Yes), Terry Weidert (Yes), Vincent B. Schibi (Yes).

Appraiser's Parcel Search Agreement – David Thornton

Commissioner Terry Weidert made a motion to authorize the Chairman's signature on an Appraiser's Parcel Search Agreement between Labette County and David Thornton; the fee of \$225.00 has been paid. Resolution No. 2025-20-A

Dust Control

Public Works Director Sandy Krider and Assistant Public Works Director Ralph George presented bids for dust control. Commissioner Terry Weidert made a motion to accept the bid from Scotwood Industries, Inc. for dust control in Labette County. The 2025 cost will be \$444.80 plus sales tax for 400 feet (400 feet by 18 feet of roadway). An additional surcharge of \$50.00 will be added, which is the same charge as last year. The other quote was from Platte River Dust Control with a quote of \$560.00 plus tax and a \$50.00 surcharge. Tom Barrett seconded the motion.
