Douglas Allen made a motion to accept the low quote received for the purchase of a Canon IR Advance C5535i III digital color B&W MFP with an extra paper deck, that came from Lakeland Office Systems, Joplin, MO, for \$7,901.92, payable from Appraisal Capital Outlay fund. The contract also includes a yearly maintenance fee of \$2,036.00, and charges for overages on B&W copies of \$.0074 and color copies of \$.0500. Fred E. Vail seconded the motion.
