November 30, 2020**

Convene

Chairman Lonie R. Addis called the regular session of the Labette County Board of Commissioners to order at 9:00 a.m. on November 30, 2020 at the Commission Room. Attendance: Lonie R. Addis, Present: Cole J. Proehl, Present, Fred E. Vail, Present.

Credit Card Approval

Commissioners agreed to apply for a credit card for incoming Register of Deeds, Raymond Scales, who will be sworn into office on January 11, 2020. The card limit will be set at \$3,000.00.

Sheriff Eichinger – Duty Weapon

Commissioners agreed that Sheriff Darren Eichinger, be allowed to keep his service revolver, Serial #BHDL 750, upon his departure from employment with Labette County.

Indigent Defense Agreement – Adamson – 2021

Commissioner Cole J. Proehl made a motion to authorize the Board of Commissioners' signatures on an Agreement between the Labette County Board of Commissioners and Shane Adamson as Indigent Defense Attorney for the year of 2021 at a rate of \$2,600.00 per month plus any associated expenses. Vail made a motion to authorize the prepaid contract between Bartlett Cooperative Association and Labette County for Unleaded gas at \$1.737 for 65,000 gallons equaling \$112,905.00. Cole J. Commissioner Fred E. Vail made a motion to authorize the contract between Bartlett Cooperative Association and Labette County for Clear #2 Diesel at \$1.865 for 80,000 gallons equaling \$149,200.00. Cole J. Proehl seconded the motion. The motion passed by vote: Lonie R. Addis (Yes), Cole J. Proehl (Yes), Fred E. Vail (Yes).

Commissioner Fred E. Vail made a motion to authorize the contract between Bartlett Cooperative Association and Labette County for #2 ULSD Red Diesel at \$1.605 for 42,000 gallons equaling \$67,410.00. Cole J. Proehl seconded the motion. The motion passed by vote: Lonie R. Addis (Yes), Cole J. Proehl (Yes), Fred E. Vail (Yes).

Grader Storage

Chairman Lonie R. Addis made a motion to authorize the purchase of a 20x50x14 mobile carport for \$11,864.00 installed, from Tri State Carports, Coffeyville, KS, payable out of Public Works Capital Outlay Fund. Other quotes were from Cardinal Carports, Mount Airy, NC at \$13,165.00, and Coast to Coast Carports, Knoxville, TN at \$15,626.94.

Noxious Weed Chemical Bids

Noxious Weed Supervisor Ralph George presented the Commissioners with a spreadsheet of the chemical bids from three suppliers – the quotes include Escort, Outrider, Glyphosate, 2,4-D Amine and Surfactant (these chemicals will be for county use only):

Commissioner Fred E. Vail made a motion to authorize the Noxious Weed Department to purchase the 2021 chemicals from Nutrien Solutions for a total cost of \$26,767.90.
