# Resolution 2025-42-L

Commissioner Tom Barrett made a motion to authorize the commission signatures on Resolution 2025-42-L Prohibiting the use of designated roadways as through ways by certain vehicles. This restricts commercial vehicles on Saline Road between 17,500 Road and 16,500 Road and on to Gate 7 of the Great Plains Industrial Park. It also restricts the speed limit from the intersection with 17,500 Road to 16,500 Road and on to Gate 7 of the Great Plains Industrial Park shall be 45 miles per hour. Stop signs shall be placed at the following intersections:

18,000 Road and Saline Road controlling the east and west traffic on 18,000 Road

17,500 Road and Saline Road controlling the east and west traffic on 17,500 Road

16,500 Road and Saline Road controlling the east and west traffic on 16,500 Road

This resolution is effective upon publication in the official county newspaper. This resolution shall apply to agricultural transportation purposes. Labette County sets the fine amount for a commercial vehicle traveling in the designated area described above shall be a violation in the amount of up to \$500.00 per incident.
