### **September 22, 2025**

#### **Convene**

Chairman Vincent B. Schibi called the regular session of the Labette County Board of Commissioners to order at 9:00 a.m. on September 22, 2025, at the Commission Room. Attendance: Tom Barrett, Present, Vincent B. Schibi, Present, Terry Weidert, Present.

#### **Approval of Minutes**

#### **Courthouse Closures**

The amount needed annually to get a seventy percent match is \$24,000.00.
